HISTORY:

In 2016, the City received \$1,700,000 from CDBG under the General Allocation NOFA. The State allows for these funds to be expended and projects to be completed within a 36-month contract term. The following projects were completed with these funds:

- Waterline Replacement Project
- Code Enforcement Program
- Capital Improvement Program in low/mod block group areas.

The project has been completed and the grant will now be closed out with the State.

The City is required to hold a public hearing to discuss the grant accomplishments and submit a closeout certification to the State. Upon direction from the Council, staff will submit the final closeout package to CDBG.

DISCUSSION:

The City has utilized CDBG funds many times in the past and continues to do so. The funds received are 100% grant funds and have been critical in assisting the City complete various projects in the City.

The projects and programs have now been completed. The City will be applying for additional monies from CDBG this year.

FISCAL IMPACT:

The CDBG funds of \$1,700,000 were 100% grant funded and all dollars available were spent and drawn down from the Stat that were needed. As required by the State, the City also committed \$2,325 in local monies towards the planning study (CIP Plan) as those carry a 5% match.

RECOMMENDATION:

Direct Staff to submit a CDBG Application to the Housing and Community Development Department on February 14, 2020 and execute attached resolution authorizing the application.

BACKGROUND:

On January 21st, the California Department of Housing and Community Development (HCD) announced the availability of approximately \$60 million (\$30 million in 2019 funds and \$30 million in 2020 funds) in funding for the CDBG program through their Notice of Funding Availability (NOFA). Funding from this NOFA can used for a variety of activities, including public facilities, infrastructure, public services, housing and economic development.

On January 14th, staff held a public hearing to review and discuss the potential submittal of a grant application to the State CDBG Program. At this meeting, the new changes in the application were outlined, and the public was given a chance to learn more about the CDBG Program. No public comments were received.

On November 5, 2019, staff brought the potential application to Council to seek approval for pursing these grant funds and incurring up-front costs to ensure a project was ready for submittal. Staff has been preparing engineering/design plans, environmental documentation and other application items based on Council direction at that meeting.

DISCUSSION:

New this year, HCD will be accepting infrastructure projects through an Over the County (OTC) process, which will be on a first come first serve basis. In order to be eligible under the OTC process, applications must be shovel ready, meaning all engineering and design is completed, and the environmental process has been met. City staff has met and discussed potential projects that would be considered potential projects for this application. In order to maximize funding, staff has recommended an application be submitted for the following:

Sewer Line Replacement Project Up to \$3.5 Million (application maximum)

FISCAL IMPACT:

<u>RECOMMENDATION</u>:

Accept Recreation commission recommendation and host a Fall 4 week Street Fair.

BACKGROUND AND DISCUSSION:

The Street Fair has been running in some capacity since 2006 and it went from 1 month to 2 months to 6 months. For the past 3 years the Street Fair was developed into a Certified Farmers Market and the management was paid for by a grand from the USDA managed by Merced County Health Department. The grant ended 9/29/19.

In light of financial constraints the department has been asked to reduce expenses by 10%. Programing that will be affected by cuts is The Street Fair. This item was presented at the December 17, 2019 meeting and it was recommended that the item be taken to the Recreation Commission for input. At the January 23, 2020 Recreation Commission Meeting the commission voted 6-0 to make the event just 4 weeks and hold it in the month of October. Holding it for just 4 weeks will allow the program to almost break even and attract more vendors and entertainment for this short period of time. There was also input from the high school students and staff that due to fundraising limitations at the high school there will most likely be a number of clubs interested in using the Fall Street fair as a fundraising platform.
